Partially Compliant

The Parish Council's website is partially compliant with the Website Content Accessibility Guidance (WCAG) 2.1 AA Standard due to non-compliance of:

Some images do not have a text alternative, sousing a screen reader cannot access information. This fails WCAG 2.1 success criteria 1.1.1 (non-text content).

From September 2020 the Parish Council will ensure that all images have a text alternative.

Disproportionate Burden

The Parish Council under navigation and accessing information from non-readable PDF's prior to September 2020 will be unable to change these documents due to an unreasonable burden to change these documents as most of the Parish Council's minutes and agendas are produced in this format.

Contents not within the scope of accessibility regulations

Some PDFs, Word and maps documents are essential to the Parish Council e.g. Minutes and agendas prior to 2018, land in Hazlemere. The Accessibility regulations do not require the Parish Council to fix them.

Most used documents on the Parish Council's website:

- Minutes
- Agenda
- Future Meeting dates
- On line forms for booking the halls
- Parish Council Policies

Method of Testing

- A random sample of 10% of the website pages to include text, PDFs, movement around the website with keyboards, pictures, font, colour, size, contrast, text to sound, consistency were tested by the Clerk, to look at:
- Text content
- Images
- Interactive tools e.g Hyperlinks
- PDF's and other documents
- Test has been done on a Samsung phone

Exemptions

- PDF's and other documents produced before 23 September 2018
- Maps

Accessibility

This website is run by Hazlemere Parish Council, who wish as many people as possible to be able to use the website. A user should be able to:

- Change colour and contrast levels
- Zoom up to 300% without the text spilling off the screen
- Navigate the website using just the keyboard
- Navigate most of the website using speech recognition software
- Listen to most of the website using a screen reader

Website Pages that are not fully accessible

- All PDF's prior to September 2020

- Further testing is required on non-Samsung phones by Councillors by December 2020

Test Report 27 July 2020

To ensure the website is perceivable, operable, understandable and robust for vision, hearing, mobility, dexterity, learning difficulties, memory and mental health.

This page was tested extensively and the following applications were present:

- Icons on the top right of the website provides easy access to magnifying text and changing the contrast
- Zooming with reflow (To magnify Ctr and +)
- Keyboard-only navigation at all levels and on menus and drop downs
- Changing colours
- The tab and arrows keys can be used to maximise movement around the website
- The location is highlighted so that you know where you are on the web page
- The add on to test for text to speech etc has been tested to use with text to speech etc

Mobile Phone

• The website is accessible to a Samsung Mobile Phone, no other brands have been tested

PDFs

- Most PDFs with tables do not read text to speech
- All other PDFs do read text to speech

Pictures

• The pictures tested did have a description

Key Board Access

- The keyboard access to submenus and pop up information are available
- Visibility of keyboard and tab focus are available

Heading structure

• The headings on different pages are consistent
