To support local business and economic activity in the village

To work with the District Council to provide safe, healthy and timely opportunities for recreation, leisure and education, and to provide, improve and maintain play equipment, allotments and public recreation spaces

To support the work of village voluntary organisations through grants and practical support

To increase public involvement in the community by ensuring the parish council and its activities are open, transparent and accountable to residents

To promote, within our community, activities which support the principles of environmental sustainability and an ethical society, and working to keep our public places clean and safe

To ensure that Councilors and Staff have access to high quality training and development opportunities and that they meet all required standards, for example working towards achieving Parish "General Power of Competence" status
